- 18. Over recent years difficulties within some councils have resulted in the need for monitors, mediators and arbiters. The 2023 Arbiters Report on Darebin Council estimated that \$600,000 had been wasted in just two years to deal with these failures. There have also been issues in Brimbank, Glenelg, Hume, Knox, Moira and Yarra Councils. What would you do to ensure that your council deliberates effectively and respectfully? (100 words maximum)

I will show respect to my fellow councillors and promise to deliberate in good faith. I will act in a professional manner at all times. I will value others viewpoints and not

be blinded by my own preconceived ideas. I will ensure all members of the discussion have the opportunity to contribute. I acknowledge that it is OK for myself or others to change their mind. I will not hurry deliberations in the interest of time.
